I am reaching out in regard to Commissioners outstanding requests. Below are tallies of outstanding requests separated by whether or not they are overdue.

Some notes regarding Commissioners Myers and Rowland -

The last Declaration of Search I received from Commissioner Myers is dated 7/18/24. The last message I received from Commissioner Myers is dated 10/4/24; in it he claims that he has performed searches but has not been able to access the Declaration of Search and that he planned to reach out to IT. I have reached out to the administrator of the form and confirmed that he has access to it. I followed up with him on 11/7/24 regarding his access issue and he has yet to respond. In this time, he has had opportunities to work with IT in person and as far as I know has not done so. I have followed up with him multiple times regarding overdue requests; the most recent follow up being 12/10/24. Additionally, I have one request (PRR 23462) that I have not been able to mark

complete for the Commission program due to commissioner Myers' tardiness. Commissioner Myers was sent this request on 6/26/24 with a due date of 8/27/24.

The last Declaration of Search I received from Commissioner Rowland is dated 9/9/24. I attempted to call her on 10/9/24; I was only able to speak to her husband who informed me that she had broken her arm and would not be able to work on requests. In this phone call I was asked to not follow up and that Commissioner Rowland would call me once she was able. She has not reached out to me in any way. I have since followed up via email on multiple occasions, the most recent being 12/10/24. Additionally, I have one request (PRR 24328) that I have not been able to mark complete for the Commission program due to Commissioner Rowlands tardiness. Commissioner Rowland was sent this request on 8/14/24 with a due date of 10/9/24.

Also of note, there are two requests (PRRs 23674 and 24147) that the public records unit has not been able to close with the requestor due to Commissioners Myers and Rowland. For PRR 23674, it was sent to Commissioner Rowland on 1/10/24 with a due date of 2/15/24; the request was sent to Commissioner Myers on 4/1/24, I did not provide a due date at that time but began following up on 8/14/24. For PRR 24147 both Commissioners were sent the request on 6/26/24 with a due date of 8/20/24.
