

The Sportsmen's Alliance \$500 Cabela's / Bass Pro Shops Gift Card Sweepstakes

Eligibility: Open to legal residents of the 50 United States and the District of Columbia age 18 or older at time of entry and who meet the eligibility requirements set forth in these rules. A random drawing will be conducted on or about October 1, 2026 to determine the winner. The first entry drawn at random from among the eligible entries will be the winner.
